The figures reported in this summary are supported by verifiable documentation available upon request made to the office of Maguire Lassman, P.A. Much of the information is a matter of Public Record. None of this information has been reviewed or approved by The Florida Bar. In five of the larger Orange County cases where Raymer F. Maguire, III and Joe W. Fixel both served as counsel, the supporting documentation has been retained by Fixel & Willis and is listed on the Summary of Recoveries Secured for Clients of both Maguire Lassman, P.A. and Fixel & Willis.

Where verifiable documentation was unavailable to support the initial offer as shown in column 2 of the chart, public records showing the initial good faith deposit into the registry of the court by the condemning authority was used as the initial offer amount. This deposit amount may have been higher, but is not lower, than the condemning authority's initial offer.

Parcels showing an initial offer of \$0.00 may reflect a business damages case. Effective 1/1/2000, the initial business damage offer was required to be made by the business; accordingly, \$0.00 is used for the initial offer amount because an initial offer by a business client was not made.

This chart excludes approximately 5% of the parcels handled by Raymer F. Maguire, III over the last 25 years due to documentation required to objectively verify the recovery results being unavailable. The parcel files excluded show recovery results consistent with the recovery results listed.
